

Village of Dieterich Sanitary Sewer Improvements



The Village of Dieterich is a growing village in Central Illinois. Due to growth and age, the Village's facultative lagoon was not providing adequate treatment. The Village evaluated an aerated lagoon and an activated sludge plant as alternatives. Due to maintenance and capital cost, the Village selected an aerated lagoon to provide sewage treatment for the Village into the future. Milano & Grunloh Engineers, LLC provided the design, permitting, and construction guidance, resident engineering and inspection for this project.



The Village of Dieterich experienced large infiltration problems and multiple maintenance issues with their lift station. Milano & Grunloh assisted the Village in securing a DCEO grant and leverage funding from South Central Illinois Regional Planning and Development Commission. Milano & Grunloh completed plans, specifications, permits and construction engineering.

## City of Effingham Wastewater Treatment Plant



This project consists of major improvements to the City of Effingham waste water treatment facilities. The improvements included a new screen, new grit collection equipment, a new activated sludge oxidation ditch, new secondary clarifier equipment, a new return sludge pumping station, new sludge transfer pumps, anaerobic digester improvements, new sludge storage tank, and all piping, fittings, site work, excavation, backfill, electrical work and demolition.

Milano & Grunloh, along with Crawford, Murphy & Tilly of Springfield, Illinois, provided the design, permitting, specifications and construction inspection for this new facility. This plant serves both rural and residential areas of Effingham County. The cost of the project was \$6,750,000.

Town of Mason

Sewer Lagoon



The Town of Mason's Sewer Lagoon and Lift Station was over 30 years old and was in dire need of being rehabilitated. ## Village of Shumway



The Village of Shumway utilized individual septic disposal systems either with or without seepage fields for waste disposal. These discharges result in ponding sewage in the ditches leading to threats of health and safety. A new sewer system was constructed to alleviate the threat to health and safety issue. Milano & Grunloh assisted in securing funding for the project and completed the plan-ning grant, design, permitting, and construction observation.

Village of Watson Lagoon



The sewage treatment system at Watson, IL consisted of a three cell lagoon system that was overloaded. The project consisted of doubling the capacity on the existing site. Milano & Grunloh provided planning services, design services and construction engineering services to increase the capacity by adding aeration with floating aerators and removing the submerged sand filter and installing rip rap around the lagoons, new piping and a rock filter. Milano & Grunloh also provided financial planning to utilize Illinois Environmental Protection Agency revolving loan funds for this project.

Village of Dieterich Main & Virginia Street Enhancements



The Village of Dieterich recently replaced deteriorated non-ADA sidewalks along Main Street and Virginia Street which had become a hazard to pedestrian traffic. The new decorative ADA-compliant sidewalks feature a red stamped concrete treatment, curbs and gutters, and decorative lighting. Not only did the sidewalk replacement reduce the hazards to pedestrian traffic, it enhanced the beauty of the downtown business district.

The Village utilized Illinois Department of Transportation ITEP Grant funds, and Village funds to complete the project. Milano & Grunloh Engineers, LLC provided Design Engineering, Grant Assistance, and Construction Inspection for the project.

Effingham Railroad

## City of Effingham Evergreen Avenue



Phase 1 of Evergreen Avenue consists of a 6,946 foot extension of Evergreen West of Effingham. Milano & Grunloh Engineers furnished the environmental report, preliminary and final engineering study and Right-of-Way on Evergreen West along with material testing, staking and construction inspection on parts of the road.



Milano and Grunloh worked with the City of Effingham to design and construct the Henrietta Street Storm Sewer, consisting of 1500 feet of 36" Storm Sewer, including boring 371 feet of 48" Steel Casing under the Railroad Right-of-Way and Illinois Route 40. Milano and Grunloh assisted in obtaining the necessary permits from the Railroad and State of Illinois. The cost of the Project was \$367,000.

The project consisted of 2,433 feet of new street, curb and gutter, and sidewalk. City of Newton Downtown Sidewalk Beautification



The City of Newton secured an approximately \$1 million ITEP Grant through the Illinois Department of Transportation. The City leveraged this grant with \$333,000 in City Funds to construct handicap ramps, detectable warnings, replacement of sidewalks which have excessive cross and longitudinal slope, removal of "double curbs" adjacent to existing sidewalks and other pedestrian friendly amenities. In addition, lighting was constructed throughout the project which will aid pedestrian's visibility at night. The project was constructed around the Square and along the west side of Van Buren Street to Water Street.

Milano & Grunloh Engineers, LLC helped the City of Newton secure the ITEP Funding and completed all engineering for the project. Since the project is located along busy State Highways, it is almost certain to "catch the eye" of some travelers and encourage them to stop and explore the City of Newton and thereby provide economic benefits to the area by increasing local tourism.
